  - 2. Amendment to By-Law 16 to be implemented as of today to allow new membership wording for the 2017/18 year so as to comply with the new WAMASC Constitution under the Incorporations Act 2015 (Rule 10(6)) to be ratified at the WAMASC AGM 5<sup>th</sup> August, 2017

#### Bylaw 16(2) Classes of membership

- a) The Association consists of ordinary members, associate, or social members.
- b) The Association may have any class of associate membership approved by resolution at a general meeting, including junior membership, senior membership, honorary membership, life membership and social membership.



- c) A person can only be an ordinary member or belong to one class of associate membership.
- d) An individual who has not reached the age of 18 years is only eligible to be an associate junior member.
- e) An ordinary member has full voting rights and any other rights conferred on members by these rules or approved by resolution at a general meeting or determined by the committee.

An associate or social member has the rights referred to in subrule (e), other than full voting rights, and is ineligible to apply for committee positions, nominate or second any class of membership in the WA Model Aircraft Sports Centre
